## Exporting to Indonesia - Fraud warning

Recently there have not been exports to Indonesia, but just a heads up. MPI informed us of fraudulent activities in Indonesia regarding SNI certificates under the Indonesian National Standard of the National Standardisation Agency in Indonesia. The target of these activities so far has been honey and horticulture exports. The fraudsters advise exporters wishing to export to Indonesia that their product requires SNI certification and asks for approximately \$15,000NZD to source this certification. Most primary products **do not require SNI certification for Indonesia.** If you are considering Indonesia, please reach out to me before engaging at all with this request for certification.

#### Exporting to Vietnam -official documents for available

Exports commence in a couple of weeks. Vietnamese importers are already visiting NZ to check out our berries. We will keep you updated on this exciting new opportunity. All the official documentation is up online now- if you are planning ahead for next season it's well worth reviewing: OAP + Pack house and producer registration.

## A reminder for those with Dams

Dam Safety Regulations are in force from May 30, 2024. If you have a dam that has a height of 4 or more metres or stores 20,000 or more cubic metres volume of water (or other fluid), you must meet The Building (Dam Safety) Regulations 2022. MPI has advised less than half the dam owners have complied. I realise the paperwork and requirements are the last thing growers need right now, but this is now law, and you don't want to get this wrong. Find the steps you must take and resources to support you here
